(Hereinafter referred to as The Client)

Where by it is agreed as follows:

- The initial contract period is to commence from **01.04.2020 to 31.03.2021**.
- The client agrees to pay for the services as indicated in **Annexure- A**. This figure would however, vary if the number of personnel are decreased or increased as required by the client.
- Pro-Interactive shall raise an invoice for the services on the **1<sup>st</sup>** calendar day of each month and the same shall be paid by client within **3<sup>rd</sup>** calendar days of the same month failing which an interest @ 2% pm on the total billing amount shall be charged extra.
- Both Parties agree that the following parts II to X inclusive form part of this contract and are bound by them.

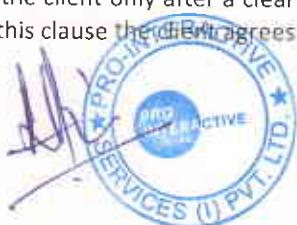

- a. Pro- Interactive will supply uniformed and trained personnel and will use its best endeavours to operate the services.
- b. The personnel supplied will be employees of Pro-Interactive and all statutory liabilities will be paid for by Pro-Interactive e.g. ESI, PF, etc.
- c. Pro-Interactive will cover its personnel for personal accident and death whilst performing the duty.
- d. Adequate supervision will be provided to ensure correct performance of the said Security services in accordance with the prevailing assignment instructions agreed upon between the two parties.
- e. All necessary reports and other information will be supplied on a mutually agreed basis and regular meetings will be held with the client.
- f. Pro-Interactive and its staff shall take proper and reasonable precautions to preserve from loss, deduction, waste or misuse the areas of responsibility given to them by the client and shall not knowingly lend to any person or company any of the effects or assets of the client under its control.
- g. The staff shall not accept any gratuity or reward in any shape or form.
- h. Under the terms of their employment agreement with Pro-Interactive, the staff shall not do any professional or other work for reward or otherwise either directly or indirectly except for and on behalf of Pro-Interactive.
- i. Pro-Interactive shall do and perform all such services, acts, matters and things connected with the administration, superintendence and conduct of the arrangements, as per the directions enumerated herein and in accordance with such directions, which the client may from time to time issue and which have been mutually agreed upon between the two parties.
- j. The client shall have the right, within reason, to have any person removed that is considered to be undesirable or otherwise and similarly Pro-Interactive reserves the right to change any personnel with prior intimation to the client, emergencies exempted.
- k. Pro-Interactive shall be responsible to look after all property and equipment of the client entrusted to it for its own use and under its control (reasonable wear and tear excepted).
- l. Pro-Interactive will not be held responsible for the damages/sabotage caused to the property of the client due to trade union/riots/mobs/armed dacoit activities or any other event of force majeure whether or not of the same nature.

**PART III CLIENT'S OBLIGATIONS**

- a. To pay for the services stipulated in the contract at the agreed price and time, failing which interest @ 2% per month will be charged.
- b. To pay separately for any additional services required by the client that is over and above the ones contained in this contract.
- c. No employee of Pro-Interactive will be contracted or employed by the client either directly or through any other agency or contractor within a period of 6 months of having left the services of Pro-Interactive. They may be recruited by the client only after a clear gap of six months from the date of their leaving the service of Pro-Interactive. In breach of this clause the client agrees to pay to Pro-Interactive twelve months salary for each and every person recruited.



Any dispute and or difference except those covered under clauses of Part 1, arising out of, or relating of this contract including interpretation of its terms will be resolved through joint discussion of the Authorised Representatives of the concerned parties, However, if the disputes are not resolved by the discussions then the matter will be referred for adjudication to the arbitration or a person appointed by the parties in New Delhi in accordance with the Indian Laws. The decision of the arbitrator shall be final and binding of the parties.
